A. Parent Choice Upon Denial of PLUS Loan

B. Title IV Authorization

The U.S. Department of Education has determined that proceeds from Title IV aid (aid funded by the federal government, including the Federal Parent PLUS Loan) must be applied to mandatory charges on the student's bill in order to help meet educational expenses. The Parent PLUS loan can only be used to pay for **non**-mandatory expenses (a book advance, health insurance, dorm damage, flex points, flight fees, lost ID fee, etc.) if you, the PLUS borrower, give written permission allowing BSU to use the funds for these expenses.
