Report MSCA Remarks – Chapter President

MSCA Chapter President Torda offered remarks. She noted the unions were united in efforts to force the new Governor to revise an insulting offer which was 5% for one year. Most employees know with rising costs, etc. this won't cover it. The current offer is now 8% with a one-year extension of their contract. This bargaining round is a coalition of unions, and it appears members will agree to these parameters. She is grateful to President Clark and his leadership team for their support and for signing the joint letter that the Council of Presidents signed. His leadership is not underestimated. The one-year contract is not acceptable and the years' worth of prep work for upcoming bargaining was for naught. The Cherish Act and Higher Education is still on the table. What will happen with the funds from the Fair Share Amendment? Dr. Torda asked Trustees to be the friend of BSU that we know you are. Do what you can do and talk to who you can talk to. This is the time to fight.

AFSCME President, Janet Cartwright, stated no one that works at BSU should be on food stamps. This increase will make a difference.

Chairperson MacCormack stated the Board recognizes the importance of faculty and staff and their work on behalf of the students at BSU to help them succeed. Trustees, too, worry about a one-year contract as they realize all the time and energy that invested in bargaining.

# Student Trustee Update

Trustee Kopellas spoke about the wealth of opportunities for students this coming spring. The return of events, which are student planned, are appreciated. Seniors are excited to graduate. Lastly, they introduced the new student trustee, Zachary Allen.

# President's Report

President Clark thanked the union leadership for their advocacy and highlighted the importance of the collective unions standing together to make a difference.

The Governor's budget appears to favor public higher education. BSU's budget line is level funded, but they will keep advocating for dollars. Meetings have been held with the Governor, Lt. Governor, speakers, etc.

#### Other updates:

- \*The president of Cape Verde visited BSU.
- \*Commissioner Ortega was on campus. He values BSU's leadership.
- \*The NECHE process is not yet concluded as they are waiting for the official letter.
- \*Admitted Students Day is taking place, which is important for recruiting students.
- \*Faculty were recognized at a recent event and were presented presidential awards.

- \*Employees were recently recognized for their length of service at BSU.
- \*Trustees, alumni, faculty and staff donated professional clothing for students for an upcoming job fair. Clothing insecurity is a real thing for our students.
- \*Commencement will be held on May 12 and 13.
- \*BSU cheerleaders are 7-time national champions; they have won four years in a row, to include 2021 which was totally virtual. The squad, 20 women and one male, scored a BSU record high to bring home the NCAA trophy.

Presentation: The Maxwell Library and the BSU Community
Provost Ismaili introduced Kevin Kidd, dean of the Maxwell Library.

Dean Kidd discussed recent developments in the Library and collaboration opportunities. The Library's role is to support educational, cultural and social missions and to bolster student success by removing barriers to information access. The Library should be welcoming and easy to navigate. They would like to hold exhibits to highlight the work of students and faculty.

There are many quiet study spaces, mentoring programs for student employees, social events and activities. They collaborate with the Lincoln Society, Bridgewater Library and libraries in the region. Looking to the future, the Library is the life blood of the institution and they want to be out in the community, tie into the curriculum and have flexible community learning space. (Attachment)

## Full Proposal for MA in Public Relations

#### Admissions Update

Overall, student admissions are on track. There are conversations on merit scholarships in the hopes of increasing the overall yield. Almost 4,200 scholarship offers have been awarded as of mid-March.

# Admissions and Advertising Strategy

There is a focus on advertising for recruitment and continual strategies being discussed. Varied audiences are targeted and divergent platforms are reviewed in the hopes of reaching many audiences.

#### FINANCE AND OPERATIONS

WBE/MBE Participation in Construction Contracts

A presentation was given at the committee meeting. Staff are

continually thinking about the equity agenda and how womenowned businesses are included in the process. There are barriers for minority-owned and women-owned businesses, and BSU would like to assist them in navigating the process. With the deployment of a new procurement system, it will assist in the equity agenda.

#### Residence Hall Rent Schedule – AY2023-24

The rent schedule was brought as an information item. The residence hall rates are based on the rate of inflation and are approved at the state level through the MSCBA. Inflationary impacts reflect the refinancing of the debt.

#### Committee Report

Chairperson MacCormack spoke about the president's evaluation. The DHE has requested a 360 evaluation every few years for all presidents. The plan is to form a small committee of Trustees this Fall in which they will gather feedback from the campus community, and a report will be drafted and shared with the full Board.

# OTHER BUSINESS

Vice President Shropshire noted there may be contracts over \$500K which will need Board approval possibly prior to the next meeting. If so, he will reach out to the Executive Committee members for a vote under the Delegation of Authority.

Chairperson MacCormack commented the recent tragedies across the nation are difficult. The Trustees are mindful of BSU's mission and it is everyone's role to create a place in the community where diversity of opinion is valued and does not result in violence. It is important to encourage people to find alternative solutions. BSU is creating the future leaders.
