General Information: International students and scholars who meet all eligibility criteria will receive a travel signature on page 2 of their I-20 or on page 1 their DS-2019.

Students and scholars who applying for a new F-1/J-1 visa are responsible for all procedures, application deadlines and fees. A visa is a stamp or sticker placed in your passport at a U.S. consulate or embassy outside the U.S. A visa is only a permit to enter the United States. Once you are in the United States, your I-20/DS-2019 becomes the relevant document that helps you to maintain legal immigration status.

You must make sure that your visa is valid for your entry or re-entry. An expired visa must be renewed at a U.S. consulate/embassy outside of the U.S. prior to re-entry. Information on visa applications and U.S. embassies is available at http://www.travel.state.gov/

Preparing for Travel: Students and scholars who plan to travel outside the U.S. and need to renew their F-1/J-1 visa must do the following:

- Request ISSS for a travel signature on page 2 of their I-20 or page 1 of their DS-2019
- Check with the U.S. Embassy/Consulate in their home country for appointments, required documents and processing times for visa renewal if applicable

Required documents for visa interview:

- A valid passport (valid at least 6 months into the future)
- Current Form I-20/DS-2019 (with valid travel signature for continuing BSU students and scholars)
- All previous Forms I-20/DS-2019
- Official Transcripts from ALL schools attended in the U.S.
- Affidavit of Financial Support and recent Bank Statement
- SEVIS I-901 fee receipt if applicable. Please visit, https://www.fmjfee.com/i901fee/index.html
- Note: Additional evidence may be required to establish non-immigrant intent.

Fees:

- ➤ Visa application fee. Please visit http://www.travel.state.gov/ to locate the website of the U.S. Embassy/Consulate in your home country for information on visa application fees and forms.
- > Please verify whether you need to pay the SEVIS I-901 fee prior to applying for your visa. Information on the SEVIS I-901 fee is available at https://www.fmjfee.com/i901fee/index.html

- ✓ I understand that it is my responsibility to check my academic status before I leave the U.S. If I am academically disqualified /dismissed while I am outside the U.S., I understand that I will be considered out of legal immigration status and will not be able to re-enter the U.S. with my current BSU I-20/DS-2019. In this case, I will have to communicate with ISSS for appropriate advice.
